

MINUTES OF THE BUSINESS MEETING Held August 5, 2024

The August 5, 2024, Business Meeting was called to order at 5:15 p.m., by President Martin. The meeting was held at the Port of Sunnyside's Business Administration Office located at 2405 Reith Way, Suite 2, Sunnyside, WA.

DISCUSSION / ACTION ITEMS:

Project Manager

- Midvale Rd The contractor ICI is currently working with Yakima County to shut down Alexander Rd overnight, so crew members have 2 full days to put in the sewer pipe. The contractor is also working on a dewatering plan with HLA to complete the sewer line below SVID's underdrain near the lift stations. The current drain water around the perforated pipe and drain rock has saturated the surrounding area. ICI is looking into dewatering the areas to get the structures and pipe placed, then backfill complete.
- Dredging Lagoon 2/3 The final tonnage weight on this project was 3,314.43, which is 14.43 tons over our target weight. The contract must be ratified for the additional cost which brings the contract value to \$2,747,565.52. Now that the project is complete the closeout process will begin.

ACTION ITEMS:

- Motion to approve the consent agenda which includes minutes of the business meeting held on July 15, 2024. Payroll issued on July 19, 2024, in the amount of \$52,712.50, payables issued on July 25, 2024, in the amount of \$1,338,199.87, totaling \$1,390,912.37. Commissioner Grubenhoff moved to approve; Commissioner Schilperoort seconded. Motion approved 3-0.
- Motion to ratify the additional cost for the added 14.43 dry tons removed from lagoon 2/3, for the Dredging Project, in the amount of \$10,781.52 and authorize Adam Smith to sign on behalf of the Port Commissioner Schilperoort moved to approve; Commissioner Grubenhoff seconded. Motion approved 3-0.
