EXECUTIVE DIRECTOR: Jay Hester presented a written report; (written report available upon request). Jay was not in attendance.

PROPERTY, DEVELOPMENT & PROJECT: Jed Crowther presented a written report and the following items were discussed; (written report available upon request).

- Jed reported that the Port was awarded a \$1.0M loan/grant from Community Economic Revitalization Board (CERB) for the Anaerobic Digestor System project on July 18. He appreciated the positive coverage by Daily Sun News, Yakima Herald Republic and KNDU-TV.
- Jed stated that our \$1.5M grant application for the Anaerobic Digestor System project was not selected at this time by Economic Development Administration (EDA) but they encouraged us to revise and improve our submittal for next quarter. We are also in the process of pursuing other funding sources.
- Jed mentioned that there are new signs at the Carnation property updating the public on the property as a Brownfield site, which are abandoned or under-used properties where there may be environmental contamination.
