EXECUTIVE DIRECTOR: Jay Hester presented a written report and the following items were discussed; (written report available upon request).

- Jay stated that he will be attending the World AG Expo in California February 12-14. 2013. They have seven companies scheduled to meet with and look forward to hearing about potential industrial growth for our area.
- Jay mentioned that the WPPA Newsletter featured a photo of Carol and an article congratulating the Port on the impressive record of 14 Consecutive Certificates of Achievement for Excellence in Financial Reporting, (CAFR).

PROPERTY DEVELOPMENT & PROJECT MANAGER: Jed Crowther presented a written report and the following items were discussed; (written report available upon request).

- Jed reported that the AWOS Airport Weather Tower easement will be bid on Feb. 7, 2013.
- Jed stated that the House Bill 1557 would likely be heard the week of February 11th. This bill would allow the Port to obtain loans from the Department of Ecology.
- Jed mentioned that Jeanie Ashe, Business Development Manager, Dept. Of Commerce visited the Port on January 28th and there was discussion for funding opportunities for redevelopment and they toured the Carnation property.

- Approve easement of Port land to the City of Sunnyside for the AWOS entry road and tower and authorize Jed to sign on behalf of the Port. Commissioner Grubenhoff moved to approve, Commissioner Matson seconded, motion carried.
