

MINUTES OF THE BUSINESS MEETING

EXECUTIVE DIRECTOR: Jay Hester presented a written report and the following items were discussed; (written report available upon request).

- Jay reported that the Port had received from Congressman Doc Hastings office a formal letter of congratulations on the Ports 50th Anniversary.
- Jay stated that the annual insurance rate was increasing by about \$1,500.00 a year to insure the district's buildings and other assets.
- Jay mentioned that Rob Faber will continue with legal education and will likely attend the WPPA Small Port's seminar and the legal portion of the WPPA Winter Meetings.
- Jay announced that there would be several block parties around Sunnyside tomorrow night for National Night Out.

- Travis stated that it has been busy, busy, busy. The anaerobic pretreatment facility construction continues on with lining of the lagoon slated to begin installation on the 18th of August.

ACTION ITEMS:

- Approve a contract increase with HDR Engineering for construction management of the Anaerobic Pretreatment Facility in the amount of \$42,300 to cover the additional cost of the PLC programming and authorize Jay Hester to sign on behalf of the Port. Commissioner Martin moved to approve, Commissioner Matson seconded, motion carried.

GENERAL COMMENTS:

Staff Comments: Vernita stated that John Van Wingerden's wife Alise had an emergency appendectomy last week and the Port received a thank you note for the bouquet of flowers that we sent her.

Commissioner Comments:

Commissioner Martin commented on the Sunnyside Chamber of Commerce Open House that he attended. He said it was fun and he enjoyed being there and visiting with the Director, Pam Turner and other folks in attendance.

Commissioner Martin reported that he attended the YCDA New Vision Board Promus Energy Forum in Granger. There was about 40-45 people in attendance to hear Dan Evans presentation relating to converting methane gas into bio-diesel fuel. Mr. Evans said his company wants to put Yakima County on the map as a national leader in the sustainable conversion of "wastes" to renewable, revenue generating products that generate economic, environmental, and community benefits. Commissioner Martin added that methane gas will be produced by the port's digester system, making it a potential candidate for a bio-diesel conversion.

Commissioner Martin also mentioned that he attended the Port of Benton function and that it was very well attended. The food was good and he had the opportunity to visit with former port commissioner, St. Clair Woodworth.

Commissioner Martin reported on the WPPA Commissioners Meeting he attended in Skamania. He said it was a good meeting, well attended and had good information.

Commissioner Matson said it was nice to be out of town for a couple of weeks in Minnesota visiting friends, despite wrecking his truck by hitting a deer. No one was hurt and he has a new truck.
