

MINUTES OF THE BUSINESS MEETING Held September 21, 2015

The public hearing on the 2016 Preliminary Budget was opened at 5:16 pm by Vice President Matson.

<u>Legal Comments:</u> Rob Faber commented that as per RCW 53.35.020 notice was given of the public hearing on the 2016 Preliminary Budget via publication in the Daily Sun News. The notice ran on Friday, September 11, 2015 and again on Friday, September 18, 2015. As of meeting time, there were no written public comments.

<u>Comments</u>: Carol commented that there were two main items to be highlighted. The first being the revised totals for the 2016 budget. The current draft budget contains the cost of the Carnation building demolition which will most likely occur in 2016 as well as a few other minor changes. The second was the tax levy request. She stated that we will be requesting the maximum legal amount of 1%.

The public hearing was closed at 5:24 pm with no further comments or questions.

PORT ENGINEER: Bob Farrell presented a written report and the following items were discussed; (a copy of the report is available upon request)

- Bob stated that the CAL has recently experienced some challenges but they are working through them.
- Bob also stated that elevated volatile acids and the resulting filaments caused a decrease in the amount of effluent from the SBR's. The effluent quality has since improved thus allowing more discharge to JD 33.4.
