- Motion to approve the contract with CH2M for Toxic Identification/Reduction Evaluation services for the amount not to exceed \$37,500.00, and authorize Bob Farrell to sign on behalf of the Port. Commissioner Grubenhoff moved to approve, Commissioner Martin seconded. Motion approved 3-0.
