EXECUTIVE DIRECTOR:

- Jay showed a video of the repairs done to the industrial line at JM Eagle. A brief explanation was given on the cause of the blockage and the repairs completed to remedy current and potential future issues in this line.
- The current MTCA legislation was also discussed. The Port of Sunnyside has joined a group in support of this most recent legislation. Commissioner Grubenhoff stated that the current sign at Carnation is not large enough for people driving by to actually read, he suggested that a larger sign be put up in its place. Jay responded that he will look into purchasing a larger sign. Commissioner Schilperoort asked what type of advertising would work better, a billboard or hard advertising. Jay responded that the majority of property sales have been a direct result of billboard and/or large ads near the property.
