DISCUSSION/ACTION ITEMS:

PROJECT MANANGER:

• The engineering report and the 90% drawings for the UV system were presented to Commission for review. Cory explained that the effluent will travel through clear basins and UV light will shine through the basins and clean the water. Commissioner Martin asked how large the building is expected to be. Corey stated it will be 48' x 48'. Commissioner Grubenhoff asked what the tubes are made of. Travis stated the tubes will be made of proprietary plastic. Commissioner Grubenhoff asked if the UV light is expected to kill the organisms in the water that are currently present. Cory responded that the UV light will kill the organism's ability to reproduce. Commissioner Schilperoort asked if an estimate on the cost of this project has been received. Jay stated it will cost approximately \$2.85 million for everything including engineering. Commissioner Schilperoort asked how much it will cost to add an additional unit. Travis stated that it will cost \$300,000 for another unit. Commissioner Martin asked how often this system will need to be cleaned. Cory responded that the system is self-cleaning.

GENERAL COMMENTS:

<u>Staff Comments</u>: Jay commented that he had a great time at the Executive Director's Seminar last week. He shared that about half of the other Ports were in attendance and he learned a lot about them.
