Executive Director:

- The ground lease with LTI, Inc. was discussed. This short-term, 6-month, lease was
 granted in response to LTI's need to relocate a portion of their fleet trucks and rail
 shipments. The property leased is the concrete slab and three acres of land off of
 Midvale Road.
- The agreement for consulting services with J-U-B was presented for approval. The agreement is for services for the Midvale Industrial Park Feasibility Study project. This project is intended to develop a plan for future land sales of these properties.
