

MINUTES OF THE BUSINESS MEETING Held January 3, 2023

The January 3, 2023 Business Meeting was called to order at 5:15 p.m., by President Schilperoort. The meeting was held at the Port of Sunnyside's Business Administration Office located at 2640 E. Edison Avenue, Suite 1, Sunnyside, WA.

<u>DISCUSSION / ACTION ITEMS</u>: Troy presented a check to the Port reimbursing ownership credits. He mentioned that he appreciates the partnership with the Port and our leadership in the community to advance economic development and promote a better quality of life. He also mentioned that he is excited about the Pacific Ag project and looks forward to future partnerships on projects with the Port.

EXECUTIVE DIRECTOR:

- **RESOLUTION 2023-01** A Resolution to approve the funding contract from CERB for the Varietal Expansion Project.
- **RESOLUTION 2023-02** A Resolution to approve the funding contract from CERB for the Pacific Ag Project.
- RESOLUTION 2023-03 The Resolution was presented to amend Resolution 2022-18
 Observed Holidays. The Resolution needed to be updated due to missing Holidays that
 had already been approved in the past. When the new list was created to add Juneteenth,
 a couple holidays were unintentionally omitted.
- **PRAETORIAN GROUND LEASE** Jay mentioned that Praetorian's lease expired last month on the 31st of December. They are currently working on cleaning out the site, and would like to extend the lease. which now expires December 31, 2023. However, Praetorian can cancel the lease at any time with a 15-day notice.

PROJECT MANAGER:

 VARIETAL EXPANSION PROJECT – Adam gave an update on the Varietal Expansion Project. He mentioned that the City of Sunnyside required a 1-hour fire rating at the north block wall requiring an increase in the wall height by 4ft. He also mentioned that due to a compaction issue, filter fabric had to be added in lieu of excavating the soil and adding rock. The Port's maintenance crew will be taking care of the landscaping and some of the smaller projects needed after construction.

- <u>Suggested Motion:</u> To approve change orders 1, 2 & 3 to M Sevigny Construction for the
 additional permit changes, soil fabric, and landscaping deduct for a total deductive amount of
 (\$7,362.73). Commissioner Grubenhoff moved to approve; Commissioner Martin seconded.
 Motion approved 3-0.
