## Operations Manager

 Parametrix – Sometime last year the Port reached out to Parametrix and asked them to do a high-level look at the plant to see where they can make improvements. Parametrix and Waterworks completed a treatment and operations enhancement study and put a presentation together to show the different options we may have for the wastewater plant. The presentation was presented via zoom.

Travis commented that if the Commissioners had any questions regarding the presentation they were welcome to reach out to him. Port staff will work to put a packet together so commissioners can review the dredging budget, alternatives offered, and capital for projects in 2024. The Port has budgeted for maintenance on the lagoons for a couple years now, but it's just never been done. The Port would like to start making these maintenance improvements now before it becomes a problem.

Jim commented that he is glad that we are moving forward with the projects on the lagoons.
