Project Manager

- **Midvale Rd** There are 216 days remaining on the project. The pave date is tracking for October 21st. A traffic control plan is being worked on to shut down the road for a day for the sewer line crossing. The equipment and lift stations are set, and the area is being dewatered to prepare for installation. Work will soon begin on the catch basin north of the gas line.
- Lagoon 2/3 Dredging The dredging project is now completed. There was a total of 3182.23 dry tons removed. We are waiting for the final weight tickets to close out the contract with American Process Group.

ACTION ITEMS:

 Motion to approve the consent agenda which includes minutes of the business meeting held on July 1, 2024. Payroll issued on July 5, 2024, in the amount of \$53,960.96, payables issued on July 10, 2024, in the amount of \$2,386,501.00, totaling \$2,440,461.96. STAFF COMMENTS: Travis commented that Parametrix is almost done with the purchase proposal for upsizing the motors on our bio reactor feed pumps. It will be a sole source equipment purchase since we already have part of the equipment. We are hoping to have the proposal by the next meeting. Parametrix is also working on drawings for moving an inlet and upsizing the outlets along with a few other small projects.

Jay commented that last week was the community interview for the Interim City Manager position. There are 2 candidates left and there will be a meet and greet at Varietal, if anyone wants to head over after our Port meeting. Jay recently attended the Executive Directors meeting in Kalama. He mentioned that there were several directors at the meeting. He was able to attend a few tours and learn new things. He has a lot of new ideas, panels, and discussions he would like to bring to the Port. He also mentioned that he leaves in a couple of days to present to CERB for the Carnation site.
